LAKE-GEAUGA USBC ASSOCIATION TOURNAMENT RULES & REGULATIONS | Certification #06190

- 1.) Any USBC female member may enter. Bowlers may participate only once. Participants will bowl four games on the same pair of lanes. At the conclusion of bowling, the bowler shall use her three highest games bowled for total series to determine the winner. To qualify for the high ACTUAL series award in the annual tournament division, only the first three games shall count. (The same holds true for USBC series awards.) The first place winner in each senior division will receive an award. In the event of a tie for the winner in any division, co-champions will be declared and duplicate awards will be given.
- 2.) All participants must be current members of the Lake-Geauga USBC. Current USBC members from another association must pay the \$8 Lake-Geauga local fee. Non-current USBC members must pay the full \$23 USBC membership to be eligible to bowl.
- 3.) All USBC rules prevail. The Tournament Director will schedule all entries and make a prize list. The Board of Directors of the Lake-Geauga USBC shall decide any question not covered by these tournament rules. The Board shall have the power to hear and act on all protests concerning the tournament.
- 4.) An entrant must use her highest final USBC average (21 games or more) from 2024-2025 season wherever bowled, including USBC Youth League averages. If your highest average is outside of Lake-Geauga, you must provide verification with your entry. If an entrant does not have a previous season USBC average, a 21 or more game average from the 2023-2024 season will be used. If neither of the above is available, she must use her current season average (minimum 21 games) and verified with a current league standing sheet.
 - a. If the average is not listed or the bowler did not bowl the previous two seasons, use the highest USBC average of 21 games or more as of Midnight, December 31st of the current season.
 - b. If no applicable average as of December 31st, use the highest USBC average of 12 games or more as of the starting date of the tournament.
 - c. Bowler not qualifying under the above rules must bowl scratch (230)."
- 5.) Prize money will be returned 100% on handicap basis. There will be at least one winner for every 5 entries. Rules 319A2, 319D, and 319E will not apply. Rule 319A3 will apply.
- 6.) The winner of each division (three games handicap series) will receive an award. Awards will also be given for the three game high actual series in the annual tournament division (first 3 games only), and high actual game in the annual tournament division. In case of a tie for first place in each division, both winners will receive an award and the first and second place prize money will be divided equally.
- 7.) The minimum number of required entries per division will be 5 bowlers. If a division has fewer entries than the minimum (at the discretion of the Tournament Director), that division can be combined with another division so that the minimum requirement is met.
- 8.) Entrants (including walk ins) must check in 45 minutes before scheduled bowling. No substitutes are permitted.
- 9.) A bowler arriving late will be permitted to bowl and shall begin play with her scores to count beginning with the frame then being bowled.
- 10.) No individual may bowl in the Local Tournament unless the entry fees are paid ""in full"". Checks or Money Orders are to be made payable to the LAKE-GEAUGA USBC and MUST accompany the entry form. Entry fees shall not be refunded except when the Lake-Geauga USBC notifies an entrant of dates and times assigned and a refusal has been received by the Tournament Director within 7 days of the date of the notice. NSF fees of \$30 will be charged. Walk-in bowlers MUST pay in CASH (\$35). No checks will be accepted the day of the tournament.
- 11.) Checks will be distributed within 30 days of the tournament date. Any protest affecting eligibility or general playing rules must be confirmed in writing to the tournament director or local association official or to the USBC before tournament prize payments are made.
- 12.) The entrant whose name appears on the entry hereby agrees that the Lake-Geauga USBC, its officers and agents shall be liable only to the extent of returning the entry fee if and when the entrant shall be prevented from bowling in the tournament through delay, unexpected yet necessary schedule change, or premature termination of the tournament which may be brought about by war, national emergency or emergencies or causes relating to fires, strikes, lockout, or labor difficulties beyond the control of the Lake-Geauga USBC.

"All entries must be received by the Tournament Director. This tournament is certified by USBC.
